

## **STARKWEATHER ARTS CENTER and DETROIT AREA WOODTURNERS EXHIBITION:**

**Eligibility:** The juried exhibition is open to all Detroit Area Woodturners members.

**Guidelines:** Entries will be juried by (an) independent juror(s) selected by DAW/SAC. A 1<sup>st</sup> place and honorable mention ribbon will be awarded in each category and one “Best of Show”.

The categories are: bowls, platters, boxes, vessels/hollow forms, pens/jewelry/kit projects, sculptural, and flatwork non-turned. Categories may change depending on number of entries. Any collaborated piece will count as one entry per individual involved and fall under the same eligibility and guidelines as individual pieces.

Artists can submit up to 3 entries for this show; one entry must be from the SAC tree. All work on entries must have been completed in the past 4 years. An entry fee of \$25, for up to 3 pieces, is required to assist with publication and administrative costs. Woodturners’ Chairperson(s) may assist in show display and set up.

Artist name, title of work & selling price must be securely attached to the back or bottom of the piece. A short (50 words or less) note card, supplied by the artist, explaining the piece, is allowed.

SAC reserves the right to reject any entry which is unsuitable in size or fragility, does not meet guidelines, or is deemed unsuitable. Please direct questions to Ken Kiernicki at 586-873-6471 or [shopperken@yahoo.com](mailto:shopperken@yahoo.com).

A commission of 30% will be deducted from the sale price of artwork sold. All artwork submitted **MUST** be available for purchase. **(If you are not willing to sell the artwork, do not submit it.)** Artist is responsible for delivery and pick of entries to SAC.

Submission of work shall constitute an agreement to comply with all conditions set forth in this prospectus. The show’s juror reserves the right to final selection of accepted work. All accepted work will remain as placed by SAC and may not be withdrawn before the exhibit closes.

All entries will be handled with all possible care, but SAC/DAW is not responsible for loss or damage. Permission to photograph accepted work for publicity shall be understood to be granted, unless specifically denied.
